You are entitled to a Concession Card if you live in South Lanarkshire* and either:

- Receive financial assistance through any of the following benefits:
 - o Income Support
 - o Housing Benefit
 - Council Tax ReductionSkill Seekers Allowance
 - Working Tax Credit (in some cases)

(Please note: if you receive any of the above benefits, you can apply for your spouse/ partner/ children under the age of 16.)

- Employment and Support Allowance (Please note: only includes dependants if accompanied by any of the benefits listed above.)
- Long term Incapacity Benefit
 (Please note: only includes dependants where benefit includes partner/child allowance.)
- Job Seekers Allowance, Personal Independent Payment/Disability Living Allowance, Severe Disablement Allowance

(Please note: if you only receive these benefits, you can only apply for yourself and not your dependants.) This list is subject to change due to future changes to benefits.

How do I get an SLLC Concession Card?

You will need to:

- o Complete the form in this leaflet.
- o Provide proof that you receive one of the above benefits.
- o Provide photographic ID (e.g. Passport, Driving Licence).
- o Provide proof of your South Lanarkshire address (e.g. utility bill, Council Tax Schedule).

Take your completed application form and proof of eligibility to your nearest SLLC leisure centre.

Re-validation of Concession Card

Concession Cards are **valid for 6 months** and must be re-validated at the end of this period by taking along proof of continuing eligibility to your nearest SLLC leisure centre. Dependants must also be re-validated at this time.

*North Lanarkshire residents who hold a valid North Lanarkshire Leisure Concession and who meet our criteria, can also apply for our Concession Card at a cost of £2.00. To apply, visit any SLLC leisure centre, and show your North Lanarkshire Concession Card along with proof of eligibility for our Concession Card. Equally, a South Lanarkshire Concession Card can access North Lanarkshire Leisure facilities at concessionary rates by applying for a North Lanarkshire Leisure Concession Card at a North Lanarkshire Leisure facility.
